We Promise to assume any responsibility for your 100% total satisfaction with the material and service that is provided by *Hurst Heating and Cooling Inc.*

Agreement: This contract sets forth the comprehensive agreement between both parties and supersedes any and all other agreements, either written or verbal, concerning the subjects of this Agreement.

Customer's Right to Cancel: New Hurst Air Care Efficiency and Savings Customer (hereinafter referred to as "Customer") may cancel this Agreement within 90 Days of its inception by mailing a written notice of termination to Hurst Heating and Cooling Inc., 102 Pacific St. Monroe Center, IL 61052. In the event of cancellation by Customer, Customer shall receive a pro-rated refund of the payments made by Customer for current term of this agreement.

Company's Right to Cancel: *Hurst Heating and Cooling Inc.* reserves the right to immediately terminate the Agreement in the event: (1) Heating and/or air conditioning equipment or accessories are installed in Customer's home by a company other than *Hurst Heating and Cooling Inc.*; (2) Customer has any part of the heating and/or air conditioning system serviced by a company/individual(s) other than Hurst Heating and Cooling Inc.; or (3) Customer fails to fulfill the payment terms agreed to on the front side of this Agreement.

Equipment: The annual investment to be paid by the Customer under this Agreement is based upon the maintenance of the equipment and accessories listed on the face of this Agreement as a complete heating and/ or air conditioning system. Customer may not delete equipment or accessories from the annual maintenance provided hereunder. In the event additional equipment is added to Customer's heating and/or air conditioning system, the same will be covered at an increase of the annual charge. Once purchased from *Hurst Heating and Cooling* equipment must be maintained to comply with Armstrong Air Equipment 10 year warranty.

Appointments: Customer agrees that all appointments scheduled under this Agreement will be scheduled *Hurst Heating and Cooling Inc.*'s normal business hours of 8:00a.m. - 5:00 p.m., Monday – Friday.

Transferability: This Agreement is transferable, subject to a minimal fee, to the subsequent owner of the home in which the equipment and accessories are located, provided *Hurst Heating and Cooling Inc.* receives written notification of the sale of the property within 60 (sixty) days of transfer.

Automatic Monthly Credit Card Debit or Checking Account Debit: I understand that the monthly fee will continue until written notice of termination is received by *Hurst Heating and Cooling Inc.* at 102 Pacific St., Monroe Center, IL. 61052. Allow up to two weeks for termination processing. Early termination of the Agreement during the initial membership will result in a pro-rated refund to the credit/debit card originally provided in the Agreement.

Warranties and Limitations on Warranties: *Hurst Heating and Cooling Inc.* warrants that all work performed hereunder will be completed in a workmanlike manner and said work shall be free from defects in workmanship for a period of six (6) months from the date said work was performed. Only the manufacturer's warranty is provided on any parts or materials provided in connection with the work. *Hurst Heating and Cooling Inc.*'s obligation for defective products and/or workmanship or any damage caused thereby and customer's exclusive remedy, shall be limited to the replacement of any defective parts or workmanship and shall be conditioned upon *Hurst Heating and Cooling Inc.* receiving actual written notice of said defects within the applicable warranty period(s). THE FOREGOING WARRANTIES ARE EXCLUSIVE AND IN LIEU OF ALL OTHER EXPRESSED OR IMPLIED WARRANTIES INCLUDING, BUT NOT LIMITED TO. IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE, *Hurst Heating and Cooling Inc.* SHALL NOT BE SUBJECT TO AND DISCLAIM ALL CONSEQUENTIAL, INCIDENTAL, AND CONTINGENT DAMAGES WHATSOEVER.
